INTRODUCTIONS**

Judith Hardcastle, Chair, welcomed folks to Presbytery at the General Meeting of BC Conference.

**AUTHORITY & CALL TO  
ORDER**

Pursuant to the authority of the 2011 Spring Meeting of Kamloops-Okanagan Presbytery (KOP), the 2011 May (Conference) meeting was Called to Order at the Penticton Trade & Convention Centre, Penticton, BC and was declared open to conduct the business properly before it, Chair Judith Hardcastle presiding. A quorum was present and a blessing offered.

<b>AGENDA</b>	Judith Hardcastle outlined the agenda for this gathering time.  <i>MS (S. Sullivan / M. Ashbaugh) that we adopt the agenda as presented. <b>Carried</b></i>
<b>MINUTES OF PREVIOUS MEETING</b>	<i>MS (R. Robertson / A. Rutley) that the minutes of the February 18-20, 2011 meeting of Kamloops-Okanagan Presbytery be received for information. <b>Carried</b></i>
<b>CORRESPONDING PRIVILEGES</b>	<i>MS (T. Meyer / S. Hershey) that Corresponding Privileges be granted to visitors and guests to this meeting of Kamloops-Okanagan Presbytery. <b>Carried</b></i>
<b>LEADERSHIP CIRCLE</b>	Leadership Circle has not met since the Spring Presbytery Meeting, but Judith Hardcastle reminded folks that Karen Medland will assume Chair of Presbytery at the rise of Conference.
<b>CORRESPONDENCE</b>	We have received a certificate of thanks from MacKenzie Camp.
<b>MANAGEMENT TEAM</b>	<b>Education &amp; Students</b> – Sue Sullivan, co-chair, reported that Diane Robinson, LeAnn Blackert, Leanne Benoit will be recognized into their ministries on Sunday. There are a number of discernment committees in the works – there are no new students coming up.  <b>Pastoral Relations</b> - Martha Ashbaugh reported that Pastoral Relations has not dealt with any crises. Joanne Koster has been appointed for 3 years as Presbytery Youth Minister, and is taking the BC Conference Certificate Programme in Youth Ministry. Keremeos Ecumenical Parish and Princeton are working together to call, as two separate Pastoral Charges, Nick Judson to work half-time with each of them, for a full-time call. Jeff Seaton has been called to Trinity United Church Vernon and Jim Hannah has been appointed to Winfield United Church.
<b>GRANT APPLICATIONS</b>	<i>MS (S. Hershey / N. Hendrie) that we forward the Technology Support Grant for St. Andrew's United Church, Lillooet in the amount of nine-hundred, eighty-six dollars and twenty-four cents (\$986.24) to General Council through BC Conference with our concurrence. <b>Carried.</b></i>  <i>MS (S. Hershey / N. Hendrie) that we forward the Church/Manse Modernization and Improvement Grant application for Oliver Pastoral Charge in the amount of five-thousand dollars (\$5,000.00) to General Council through BC Conference with our concurrence. <b>Carried.</b></i>  <i>MS (S. Hershey / N. Hendrie) that we forward the Church/Manse Modernization and Improvement Grant application for Zion United Church of the Ashcroft-Clinton Pastoral Charge in the amount of three-thousand, seven hundred and twenty-four dollars and seventy cents (\$3,724.70) to General Council through BC Conference with our concurrence. <b>Carried.</b></i>
<b>RESOURCE FAIR INFORMATION</b>	Irene Hart and Wayne Atkinson provided copies of the registration material for the Kamloops-Okanagan Presbytery Resource Fair “Big Questions – Worthy Dreams” being held October 1, 2011 at Penticton United Church. Janet McDonald will be the keynote presenter and there are fourteen (14) workshops offered. Registration for the Resource Fair can be done through the Presbytery Website or via the paper registration.
<b>MANAGEMENT TEAM &amp; PENTICTON &amp; OASIS COMMISSION</b>	Steve Hershey presented some history of the Commission in Penticton, BC. Out of those recommendations, Penticton United Church and Oasis United Church have been established as two Pastoral Charges in Penticton. Steve Hershey explained that members of the Executive this morning spoke with Doug Goodwin, Conference Executive Secretary, and Jon Jessiman, Conference Legal Counsel, and have agreed to our next steps forward. The recommendation is to have a Mediator meet with both Penticton United Church and Oasis United Church in the next few weeks to make some decisions about the next steps. Also, on behalf of the Management Team and Executive, Steve Hershey apologized to Penticton United Church and Oasis United Church for having failed in this process.

Conversation followed. LeAnn Blackert offered prayers for this coming process, for Penticton United Church, Oasis United Church and the Executive of this Presbytery.
